MUST Service Centers provide food, clothing, financial assistance, and employment services to persons in financial distress. These centers distributed over 437,000 pounds of food, and 159,000 items of clothing to the community during the fiscal year ended June 30, 2012. Collectively, 415 clients were able to obtain employment, returning over \$5.5 million in wages back to the community.

4b (Code:) (Expenses \$ 1,984,214. including grants of \$ 18,905.) (Revenue \$ 104,485.)

MUST Housing programs work to address the emergency needs of persons experiencing homelessness, the transitional needs of those recovering from homelessness, and the long term housing needs of those struggling with chronic homelessness as a result of a disability. These programs provided over 78,000 bednights of rest to persons recovering from homelessness. MUST's emergency shelter serves over 1,000 persons annually, including nearly 200 children in families. MUST's supportive housing programs offer stable housing for up to 70 persons who are chronically homeless.

4c (Code:) (Expenses \$ 1,047,487. including grants of \$ 705,029.) (Revenue \$)

MUST Seasonal programs provide supplemental food and holiday assistance for families throughout a six county region. These programs provided 161,000 meals to children who would do not have access to school lunch during the summer months. During the winter holiday months, MUST provided a complete Thanksgiving meal to 976 families, and holiday gifts to 3,600 children.
